#### John Austin McDonald

Person Notes: John Austin McDonald was a member of Company K, 1st Mississippi Infantry during the Civil War. He enlisted at Iuka, MS on 19 September 1861. He was captured when the Port Hudson garrison surrendered on 9 July 1863. He died the next day. It is unknown whether he died of battle wounds or disease.
